# 2024 Regional Availability form was distributed and discussed. NOW DUE MAY 1<sup>ST</sup>, 2023

-RAC discussed and decided that the National/Brevet Course would be allowed to count toward the eligibility requirement, however, this may not be considered in the future.

# 2024 Eastern/National Application NOW DUE MARCH 1<sup>ST</sup>, 2023

-will not have to add # of judgements on this form, since it will be on judges' Regional Availability Form-NEW

\*\*\*Need to let SJD's know of the changed due dates for these forms\*\*\*

Evelyn: For the Eastern/National rotation judges have been assigned through 2024.

New assignments need to be made through 2027, which will be only a 3-year period due to covid and extension of previous rotation assignments.

All judges will need to apply or re-apply (even if they are already in the rotation).

\*\*\*To note: The National/Brevet Judges Course has not been added as on option on this form.

#### <u>Training Camp volunteer judges</u>

- -Discussion on 8 hour requirement Keep 8 hr sections for Level 8/9/10 and National Team Training Camps as they usually have Sunday morning rotations.
- -Recommendation for judges to stay until last rotation of training camp. They may stay for Open Gym, but it is not required.
- -Suggested that states NAWGJ committees support judges that are in the National rotation by helping with their travel expenses to training camps

Level 6/7/8 TC – July 12-14, 2024 National Team TC – September 13-15 or 20-22, 2024 Level 8/9/10 TC – October 18-20, 2024

#### RACC election in 2023

- -Nominations March 1st April 1st

In Good Standing List link was given – no discussion

Review discussion of breaking ties at Regionals for 1<sup>st</sup> and 2<sup>nd</sup> place -Currently at all 3 regionals, ties will be broken

Deb stated that committee volunteers are still needed at L 9/10 Regionals.

Revisited discussion regarding athletes only go to Regionals if they qualify for state team.

-Meetmaker has added to state meet entry a column where coach must say "yes" or "no" to athlete attending regionals. File can then be downloaded.

It was decided that the deadline for all entries to regionals will be midnight Sunday night following each state's Dev and Xcel state meets.

This information will be sent out to all clubs.
