Regional JO Program

6-16-16 meeting of Region 8 Committee

Brad reminded the Committee of the criteria for the All-Star trip: National or Eastern AA or Event Discussion: champions for a Club to be in "Good Standing". The requirements have been established for a long enough time that he would like to apply the "good standing" criteria to Clubs receiving Region 8 apparel for Eastern and National qualifiers. "In Good Standing" is defined as:

- 1. Host a Camp within the last 2 yeas
- 2. Send volunteer coaches to a Camp to actively work with gymnasts within the last 2 years
- 3. Send athletes to a Camp within the last 2 years
- 4. Make a \$1000 donation to the Regional Apparel Fund

Motion **Brad H** moved that our "good standing" definition for the All-Star trip be applied to the criteria for

receiving National/Eastern apparel.

If a Club has not attended a Training Camp within two years and wishes to pay the \$1000.00, the fee must be paid by the completion of Regionals. The All-Star Team is chosen as follows: a) Any athlete(s) that place(s) first in the AA get(s) first priority, b) If there are still spots available the athlete(s) with the highest AA score(s) regardless of Age Group or AA placement shall make up the remainder of the Team, c) In case of an AA tie for the last Team spot, the highest individual even score shall break the tie.

Brad H moved that an athlete attending a Club that is not in "good standing" shall not be able to Motion

attend the All-Star trip.

Regional Apparel GK Presentation 3:11

Wendy Martin, VP, Corey Fritzinger and Kylee Rogers (via Facetime) presented the 2017 GK proposal for Regional apparel. After distributing color booklets with the leo/accessory options the presentation was completed as three gymnasts modeled the choices. Wendy told the State Chairs that if GK were chosen the reps would need to know within two months if someone were needed on site at each State Meet.

Deb K informed the Region 8 Committee that Ozone was unable to present a bid this year.

Deb K appointed a Regional Apparel Committee (Shelley S, Michelle P and Joanne C) and asked that their choice of leotard color, design and style of accessory be brought back to the larger Committee.

Regional Charity - St. Jude

Discussion: Toni presented an effective method used in Florida involving more gymnast input as to which charity receives the donations. Other ideas were presented. Deb reminded the members that we had committed to having St. Jude as our Regional charity for two years. Marian D. suggested that the Regional effort needed to donate to a charity was not as effective as it had been in the past. The consensus of the Committee was that the commitment to St. Jude would be fulfilled and that we would suspend adding an additional charity.

National Collegiate Acrobatics and Tumbling Association

Deb shared a letter from Heather Ould of the National Collegiate Acrobatics and Tumbling Association informing the Committee of competitive opportunities in this newly created (2011) collegiate sport. Two universities in our Region host teams – King University (Bristol, TN) and Converse College (Spartanburg, SC) and offer varsity scholarships. Ms. Ould asked about the availability of Region 8's NCAA list, which Deb sent to her to distribute to Colleges in this association. Judges at Xcel Regionals
